## UNION COUNTY FISCAL July 23, 2013

The Union County Fiscal Court met in regular session with the Honorable Jody Jenkins presiding. Magistrates present were Day, Floyd, Voss, Wells, and Clements.

The meeting opened at 9:00 a.m. with a prayer by Bro. Jerry Manning and the pledge to the American Flag.

The Minutes of the previous meetings were approved by Magistrate Wells, seconded by Magistrate Floyd, motion carried.

Magistrate Floyd informed the Court that Hwy 130 has been worked on and the hump has been removed but during the process the base went soft and made the road have several bumps. The road will be fixed, but they have to wait for the road to settle so it may take several weeks. Magistrate Floyd made a motion to allow transfers, seconded by Magistrate Wells, motion carried.

Magistrate Wells announced that the contractor should be down this week to start working on White Road Bridge.

Magistrate Wells made a motion for the Fiscal Court to give United Family Service \$2,500.00, seconded by Magistrate Floyd, motion carried.

Judge Jenkins thanked EMA Director, Vernon Martin, the Union County Sheriff's Department, and the many more agencies that helped during the missing child search. There were 39 agencies from 2 states that helped with the search.
