

## UNION COUNTY FISCAL

The Union County Fiscal Court met in regular session with the Honorable Jody Jenkins presiding. Magistrates present were Day, Floyd, Voss, Wells and Clements.

The meeting opened at 9:00 a.m. with a prayer by Bro. Jerry Manning and the pledge to the American Flag.

The Minutes of the previous meetings were approved by Magistrate Floyd, seconded by Magistrate Wells, motion carried.

Magistrate Clements made a motion to approve the Sheriff's Tax Settlements for property, oil and franchise, seconded by Magistrate Floyd, motion carried.

Debbie McClanahan, Director of the Union County Library was present in Court to talk about how successful the 2014 summer read and feed program was going.

Magistrate Day made a motion to award the ambulance service bid to Methodist Hospital Union County, seconded by Magistrate Clements, motion carried.

Magistrate Voss made a motion to award the pipe bid to Jabo Supply Corporation, seconded by Magistrate Floyd, motion carried.

The 2014/2015 blacktop bids tied with Magistrate Day, Magistrate Floyd, and Magistrate Voss voting for Rogers Group, and Magistrate Wells, Magistrate Clements, and Judge Jenkins voting for J.H. Rudolph. The discussion was tabled to finish the remaining of the agenda and to allow the companies to gather further information. Once the matter was brought back to the table Magistrate Day, and Magistrate Voss voted for Rogers Group, Magistrate Floyd, Wells, Clements, and Judge Jenkins voted for J.H. Rudolph, with J.H. Rudolph being awarded the blacktop bid for the 2014/2015 fiscal year.

Magistrate Voss made a motion to award the rock bid to Ratley Trucking and Rogers Group, seconded by magistrate Day, motion carried.

Magistrate Clements made a motion to approve the second reading of the 2013/2014 budget amendment, seconded by Magistrate Floyd, motion carried.

Magistrate Clements made a motion to approve the 2014/2015 Budget in the amount of \$16,917,381.22, seconded by Magistrate Floyd, motion carried.

Magistrate Clements made a motion to approve 2014/2015 salary schedule, seconded by Magistrate Floyd, motion carried.

Magistrate Floyd made a motion to approve all claims, seconded by Magistrate Voss, motion carried.

Magistrate Clements made a motion to approve transfers, seconded by Magistrate Day, motion carried.

There being no further business to come before the court, a motion to adjourn was made by Magistrate Wells, seconded by Magistrate Floyd, motion carried.
